#### 1. Definitions:

- a) Personal data information that makes it possible to identify a natural person, such as name, e-mail address, or telephone number;

### 2. Data Controller:

3. Purpose and Scope of Data Processing:

We process your personal data for the following purposes:

- a) to enable contact with us (responding to inquiries, requests, and messages);
- b) to handle messages sent via the contact form or e-mail;
- c) to send information about our activities, including marketing content (if you have given your consent).

Scope of the processed data:

- a) e-mail address,
- b) name and surname (if provided),
- c) phone number,
- d) any other data voluntarily included in your message or attachments.

Providing your data is voluntary but necessary for us to respond to your inquiry.



## 4. Legal Basis for Processing:

We process your personal data on the following legal grounds:

- a) Article 6(1)(f) GDPR our legitimate interest in responding to your inquiry or conducting correspondence;
- b) Article 6(1)(a) GDPR your consent, for example, to receive commercial or marketing information.

#### 5. Data Retention Period:

Your personal data will be stored:

- a) for the time necessary to respond and complete correspondence;
- b) in the case of marketing activities until consent is withdrawn;
- c) for the time required to pursue or defend against legal claims for the limitation period applicable to such claims.

## 6. Data Recipients:

In limited cases, your personal data may be shared with:

- a) entities providing IT and hosting services to us;
- b) an accounting office that supports us with financial settlements and record-keeping;
- c) providers of e-mail and office software services (Google Ireland Ltd);
- d) providers of newsletter or mailing services, if you subscribe to our newsletter (e.g. subscription management platforms).

#### 7. Your Rights:

In accordance with the GDPR, you have the right to:

- a) access your personal data;
- b) rectify your personal data;
- c) withdraw consent, if it was the basis for processing;
- d) erase your personal data ("right to be forgotten");
- e) restrict the processing of your personal data;
- f) transfer your personal data;
- g) object to the processing of your data based on legitimate interests;
- h) lodge a complaint with the competent data protection authority.
